LEADERSHIP

Since 1963, the Pennsylvania Council of Trout Unlimited (PATU) has been working with local, state, and federal partners to conserve coldwater habitat and promote healthy native and wild trout fisheries across Pennsylvania. We restore streams through habitat improvement projects, conduct education and outreach programs related to water conservation and fisheries management, and work to educate the next generation about the importance of clean water and wild trout. Our council serves as a unified voice for the 49 local chapters representing 15,000 members statewide.

Mission

To conserve, protect, restore, and sustain Pennsylvania's coldwater fisheries and their watersheds, especially our wild trout resources.

Vision

By the next generation, Trout Unlimited will ensure that robust populations of native and wild coldwater fish once again thrive within their North American range, so that our children can enjoy healthy fisheries in their home waters.

WORK THAT CONNECTS

Through working with our chapters and partners across the state, PATU aims to develop strategies and provide resources that cultivate leadership, engage people (especially youth) in hands-on conservation projects and advocacy efforts, recruit and retain a diverse membership throughout our communities, and maximize synergies between our organization and like-minded agencies, organizations, and partners.

Trout in the Classroom

For over 15 years, PATU has been partnering with the PA Fish and Boat Commission (PFBC) to administer the Trout in the Classroom program statewide. Through the program, teachers and their students raise rainbow trout from eggs to fingerlings in classroom aquariums before releasing them into an approved waterway each spring. The following statistics were recently compiled for the 2022-23 school year:

- There were 419 TIC programs implemented across the state.
- Over 49,000 students were engaged in the program.



- Over 8,700 hours were devoted to teaching TIC topics.
- 11,600 students received fishing instruction through the program.
- Over 3,800 volunteer hours were donated by TIC community partners.
- Utilizing PATU funding and PFBC R3 Education Grant funding, we were able to award grants to 66 teachers for aquarium supplies, fishing and fly-tying equipment, field trip and release day support, and curriculum materials to support their TIC activities.

STREAM Girls/Keepers

Through the STREAM Girls/Keepers program, spearheaded here in Pennsylvania by Youth Education Chair Judi Sittler, students are introduced to watershed conservation and angling concepts utilizing principles of <u>Science</u>, <u>Technology</u>, <u>Recreation</u>, <u>Engineering</u>, <u>Art</u>, and <u>Math</u>.

Originally started as a Girl Scouts patch project, the program has been recently expanded to include youth of any gender and organizational affiliation. This year the STREAM Girls/Keepers program has held seven events with one more slated for early October. Over 80 youth were educated through the STREAM Girls/Keeper program this year. Women, Diversity, and Inclusion (WDI) Committee

The PATU WDI Committee, co-chaired by Amidea Daniel and Kelly Williams, has been working hard over the last several years to encourage more diversity at TU events and activities through hands-on leadership training and providing resources to chapters. Over the past year, the WDI Committee has:

- Held regular committee meetings to engage chapter members and partners across the state.
- Completed a PFBC R3 Education Grant to provide loaner fly fishing equipment in Environmental Justice communities. The original goal was to establish three new fishing tackle loaner sites, but seven were ultimately established. They are listed below.

focused on leadership development, partnerships, developing introductory fishing programs, and building off those programs to engage folks from all walks of life in fishing and conservation. Participants represented:

- Three partnering organizations
- PATU and National TU staff



- Supported WDI Committee members as they implemented various trainings and events throughout the year including:

 - Women's Intro to Steelhead Programs hosted by PFBC November 4-7, 2022.
 - Walk n' Wade Wednesdays hosted by Lancaster Fly Girls April 5, 12, and 19, 2023.
 - PA Steelhead Association Presentation by Amidea Daniel April 12, 2023.
 - United Women on the Fly "Fish and Hang" weekend hosted by Lancaster Fly Girls May 26 28, 2023.

• Maintained the PATU WDI website (<u>www.patuwdi.weebly.com</u>) which includes resources for chapters to utilize in their efforts to attract diverse audiences to their programs and events.

Communications

Through improved communications, PATU has worked to better serve our members and engage new and existing community partners and supporters by:

- Developing a Communications Plan for the organization.
- Continuing publication of the *Pennsylvania Trout* newsletter and My PATU monthly emails.
- Increasing utilization of social media including Facebook, Twitter (now X), LinkedIn, Instagram, and YouTube. This has led to a 47% increase in followers, a 16% increase in shares, and a 22% increase in post impressions across all social media platforms.
- Hiring a Conservation Communications Coordinator (CCC). Our first CCC was instrumental in helping us reboot our social media presence. She departed for a new opportunity earlier this year and we are currently in the process of hiring someone to fill the position and continue that momentum.

WORK THAT PROTECTS

Utilizing our strong network of chapters and partners across the state, PATU aims to protect our coldwater ecosystems and native and wild trout fisheries by providing funding, technical support, resources, and advocacy for projects and initiatives that will lead to improvements in water quality, instream and riparian habitat, and connectivity of existing wild trout populations. These efforts aim to help native and wild trout remain resilient against threats including climate change, habitat loss, resource extraction, development, and changing land use, while taking advantage of opportunities to restore and protect critical areas.

Coldwater Heritage Partnership

The Coldwater Heritage Partnership (CHP) was formed in 2002 as a collaborative effort between PATU,



the Pennsylvania Department of Conservation and Natural Resources (DCNR), the Pennsylvania Fish and Boat Commission, and the Foundation for Pennsylvania Watersheds (FPW). The program is designed to provide funding and technical assistance for planning and implementation of coldwater conservation projects across the state. The first CHP grants were awarded in 2003 and have continued for the last twenty years.

Over the last year, we worked with our grantees to finalize Round 25 (2020) and

Round 26 (2021) CHP projects. Through these two rounds we were able to fund eight planning grants to assess the conservation needs of wild trout streams across the state and an aquatic organism passage (AOP) assessment of eight Class A and naturally reproducing wild trout streams in Clearfield County (Table 1).



Mariner East 2/Revolution Pipeline Funding

Another exciting development this year is the addition of \$500,000 in funding to the CHP program through the Mariner East 2/Revolution Pipeline settlement. PATU will be working with the Pennsylvania Office of the Attorney General to oversee grants for coldwater planning and implementation projects in 18 counties impacted by construction of the Mariner East 2 and Revolution pipelines. Organizations in the following counties will be eligible for future funding: Allegheny, Beaver, Berks, Blair, Cambria, Chester, Cumberland, Dauphin, Delaware, Huntingdon, Indiana, Lancaster, Lebanon, Juniata, Perry, Washington, Westmoreland, and York.

Forever Wild



Each year, PATU awards small grants to our chapters to assist with conservation projects and education and outreach regarding coldwater conservation and wild trout streams. Since September of 2022, Council has awarded six Forever Wild grants to chapters across the state (Table 3).

Trout Policy Committee

Committee Chair Dave Rothrock attended nearly all PFBC Fisheries and Hatcheries Committee meetings, as well as all but one of the quarterly Commissioners' meetings. He met with PFBC staff each quarter to discuss important topics related to upcoming Commissioners' meetings as well as issues PATU considers important.

PATU has supported the proposal to require all entities to provide a Notice of Stocking to the Commission which is expected to be implemented as of January 1, 2024. This will provide Commission staff with information regarding the stocking of all species across the state.

While the proposal to require all entities to request a Stocking Authorization from PFBC was tabled, PATU continues to pursue



keeping the discussion alive with hope that this will be approved by the Commissioners for implementation soon. We believe this will be an important tool to allow PFBC to better manage the state's fisheries.

PATU has supported PFBC's effort to change the regulation of the 12 Class A wild brown trout stream sections which are also stocked and are currently managed under general trout regulations. The

proposal is to allow harvest of the stocked rainbow trout and require that all brown trout must be released unharmed. This will go a long way in protecting these valuable wild brown trout populations.

Conservation Committee

Over the last year, the Conservation Committee chaired by Brian Wagner has completed the following activities in support of PATU's strategic goals:

- Reviewed Forever Wild grant applications (see Table 3).
- Updated PATU's policy on Stream Channelization & Maintenance.
- Raised awareness of PFAS (Forever Chemicals) & Neonics.
- Provided a support letter to David Coughlin, Professor of Biology at Weidner University for a proposal to determine effects of climate change on native brook trout.
- Assisted chapters with local issues including:
 - Proposed water withdrawals by Nicholas Meats on Fishing Creek in the Narrows, Clinton County (Susquehanna Chapter and Lloyd Wilson Chapter)
 - Keystone Sanitary Landfill permit to discharge treated leachate into Little Roaring Brook, Lackawanna County (Lackawanna Valley Chapter)
 - Investigation of "cloudy" water conditions (possibly quarry related) in Honey Creek, Mifflin County (Penns Creek Chapter)

WORK THAT SUSTAINS

Development Committee

This was the first year for the reconstituted PATU Development Committee. Bob Neu of the Penns Woods West Chapter was appointed Chair at the Annual Meeting in September 2022. Since that time the committee has undertaken the following activities to help sustain the work of our organization.

A fundraising database was created to track all aspects of individual and institutional giving going forward; we are in process to find a cost-effective way of sharing it among authorized users. We re-established PATU's certification by the Commonwealth as an Educational Improvement Organization, so that business contributors can receive tax credits for donations to Trout in the Classroom and STREAM Girls/Keepers under PA's EITC (Educational Improvement Tax Credit) program. We recently received our first corporate contribution of this nature.

Through PATU member Al Budinsky we were able to access a Trout in the Classroom support grant from the Terracon Foundation; our thanks to Al for spearheading this effort.

We used the text of the Terracon Foundation application to develop a grant-request template, including current TIC participation statistics, for any chapter who needs assistance in applying for local funding for its TIC program.

THE FUTURE IS BRIGHT



The last few years have been challenging due to the global COVID-19 pandemic; however, PATU is poised to move forward with our efforts to protect and conserve coldwater habitat and wild trout fisheries across Pennsylvania.

Plans to Connect

Communications - To better engage our communities in our conservation mission, we plan to continue making improvements to our communications systems. This will entail hiring a Conservation Communications Coordinator (underway) and utilizing the recently developed Communications Plan to make sure we are using all available means to engage with our members, partners, and supporters. We will make a concerted effort to generate and share relevant content across both our print media and social media platforms. We will also work closely with our chapters to plan and advertise events and training opportunities.

Youth Education - We plan to continue working with chapters and other conservation partners

to host STREAM Girls/Keepers programs in each region of the state. Those wishing to host a program for the coming year should reach out to the Youth Education Committee for resources and support.

Diversity - The WDI Committee is planning to continue offering training and resources to support diversity within our organization. The WDI Committee will have a presence at the 2024 Lancaster Fly Fishing Show in March and will host the annual Women's Leadership Retreat on May 17-19, 2024, in Port Matilda. There are also regional events being planned by the WDI Committee for the coming year.

Keystone Coldwater Conference - The Keystone Coldwater Conference will be held February 23-24, 2024, in State College bringing together folks from across the state to network and learn about the latest in coldwater conservation. This year's theme will be "The State of Coldwater Conservation in PA – Identifying Priorities and Building Synergy to Enhance Conservation Outcomes". 2023 Annual Report

Plans to Protect

Conservation – In order to support conservation of coldwater habitat and wild trout fisheries across the state, PATU will continue to offer Coldwater Heritage Partnership grants as well as Forever Wild grants to

fund planning and implementation projects. The Conservation Committee will continue to monitor issues affecting wild trout and their watersheds and will offer support and guidance to our chapters as needed to protect coldwater resources.

Policy & Advocacy – The Trout Policy Committee will continue to engage with state level agencies (primarily PFBC) to communicate PATU's goals regarding wild trout management and ensure that Council has a seat at the table when management decisions are being made. Council will continue to work with National TU staff here in Pennsylvania to advocate for policies and legislation that benefit conservation of native and wild trout and coldwater resources.



Plans to Sustain

Development - In the coming year, we plan to develop a grant template to help chapters access funding to support local STREAM Girls/Keepers programs. We also plan to make an assertive fundraising effort with the forthcoming Annual Appeal letters, coming out in November. We also hope to begin accessing new foundations and corporations on a regular basis, to build a productive approach to both project-oriented and general-operating funds for the current and future years.
